## **TXCDBG Engineer 2021 2020**

George Huffman addressed Council concerning awarding a contract for engineering services for the 2021-2022 Texas Community Development Block Grant for water system improvements. George explained proposals had been received from two engineering firms. After a scoring process determined by TXCDBG standards, Jacob & Martin received the most points. Ben Tucker made the motion to award the contract to Jacob & Martin if grant funding is received. Debra Haehn seconded the motion. All members present voted "Aye".

#### **Water Treatment Plant Contractor**

George Huffman addressed Council concerning authorizing an Independent Contractor Agreement between FS Water Specialist LLC and the City of Archer City for the operation of the Water Treatment Plant. Debra Haehn made the motion to approve the contract. Paula Bradley seconded the motion. All members present voted "Aye".

## Generator

George Huffman addressed Council concerning the purchase of a generator for the water treatment facilities using the remaining USDA grant funds. Zac Beck made the motion to table the item. Debra Haehn seconded the motion. All members present voted "Aye".
