### **NEW BUSINESS**

### Substandard Structures Located at 204 S. Vine and 301 W. Elm

Cowart stated the structure at 204 S. Vine had burned and no longer existed except for the debris from the fire and the structure at 301 W. Elm had collapsed. No action taken.

# 4<sup>th</sup> Quarter Investment Report

# **Employee Comp Time Benefits**

George Huffman addressed Council concerning a partial disbursement of accrued employee comp time benefits and recommended the City purchase up to 50% of accrued comp time, at the employee's current regular hourly rate, for any employee that has accrued comp time in excess of twenty hours. Any employee with remaining accrued comp time in excess of eighty hours would be required to use those hours prior to September 1, 2017. After September 1, 2017 that maximum allowed accrued comp time hours would be eighty hours. Jerry Phillips made the motion to approve the partial disbursement of accrued employee comp time benefits. Debra Haehn seconded the motion. All members present voted "Aye".
