#### TML Health Benefits for 10/1/22-23

Kim Whitsitt addressed Council concerning the renewal of the employee group health, dental, vision, life insurance and disability plans with TML Health Benefits Pool for the 10/1/22-23 term. After further discussion Debra Haehn made the motion to approve the renewal of the plan with Option 2. Option 2 increases the annual deductible to \$2,000.00 with a \$6,000.00 annual out of pocket. Paula Bradley seconded the motion. All members present voted "Aye".

#### **Employee Monthly Insurance Stipend**

Kim Whitsitt addressed Council concerning authorization for a medical insurance benefit stipend for full time eligible employees who opt out of the TML Group and are insured under another health insurance plan. Megan Randall made the motion to approve the insurance stipend. Billy Burks seconded the motion. All members present voted "Aye".

#### **Bids for Installation of Generators**

George Huffman addressed Council concerning the award of a bid for the installation of two new generators and stated three (3) bids were received. After further discussion Leslie Hash made the motion to approve the bid from Archer Electric for \$82,541.00 for installation at the water treatment plant and \$16,198.00 for installation at Lake Kickapoo pump station. Megan Randall seconded the motion. All members present voted "Aye".
