Public Hearing on Tax Increase Open Regular City Council Meeting & Budget Workshop Thursday, September 15, 2022, 7:00 P.M.

The Mayor Pro-Tem and City Council of the City of Archer City, met for a public hearing on the tax increase, open regular city council meeting and budget workshop on Thursday, September 15, 2022 at 7:00 p.m. in the City Council Chambers, 116 S. Sycamore, Archer City, Texas.

Call to Order

Mayor Pro-Tem Paula Bradley called the meeting to order at 7:01 p.m. Billy Burks gave the invocation and Mayor Pro-Tem Bradley led the Pledge of Allegiance for the United States and Texas flags.

Public Hearing on Tax Increase

Mayor Pro-Tem Bradley convened the Public Hearing on the tax increase at 7:03 p.m. and stated a tax rate of .76180 per \$100 valuation has been proposed for adoption by the governing body of the City of Archer City. This rate exceeds the no new revenue rate, and state law requires that a public hearing be held by the governing body before adopting the proposed tax rate. The proposed tax rate will raise more total property taxes than last year by \$62,199.00 or 12.84% and of that amount \$6,243.41 is tax revenue to be raised from new property added to the tax roll this year.

Public Comments

Larry Holloway, Jackie Ditto and Michael Bradshaw addressed Council with concerns over the proposed City contract with AMR for emergency medical service operations. Concerns included AMR taking over the Archer City Ambulance Service and taking City tax dollars out of the City to pay AMR. Michael Bradshaw made a request to pursue other options to save money such as using first responders while waiting on an ambulance to respond from Wichita Falls. Mr. Holloway also addressed code enforcement.

Leslie Hash made the motion to approve the Consent Agenda. Megan Randall seconded the motion. All members present voted "Aye".

Resolution 449 4B Archer County Shooting Sports Complex

Ordinance 365 Amending Water Rates and Solid Waste Fees
