**Hours of Operation**

- Monday –Saturday 1-6 pm
- Tuesday - Family Swim Night 6-8 pm – Admission \$1.00/\$2.00 after 6:00 pm
- Sunday 2-6 pm

Archer City Residents

- 17 and under \$2.00
- 18 and over \$3.00
- Monthly Pass \$30.00
- Season Pass \$60.00

Non Archer City Residents

- 17 and under \$3.00
- 18 and over \$4.00
- Monthly Pass \$40.00
- Season Pass \$80.00

**Weather Policy**

- During storms the pool will be closed and the entire area cleared of patrons. Due to limited shelter, patrons are encouraged to leave the facility. Others must remain within the shelter of the pool house or their car. The pool will reopen 15 minutes after the storm passes.
- “If you can see it, flee it! If you can hear it clear it!” If lightning is seen or heard the pool will be evacuated for 30 minutes. If no other occurrence of lightning is seen or heard during the 30 minute evacuation, patrons will be readmitted to the pool.

**Private Pool Parties**

- A \$50 deposit is required to rent the pool for all private parties. The deposit is due at the time of booking the party. The deposit will be returned only if the pool complex and restrooms are clean and there is no damage to the pool area, restrooms, or furniture. Renters will be responsible for damages or cleaning costs in excess of the \$50 deposit.
  - Private Party Fees
    - AC residents \$100 per private party, 2 hour limit, up to 25 people
    - Non AC residents \$125 per private party, 2 hour limit, up to 25 people
    - 25 - 50 people will be an additional charge of \$25
    - Over 50 people please call for a quote
    - If the party will be composed primarily of small swimmers (Age 6 or less), there will be an additional fee of \$25 for an extra lifeguard
  - Private Party Hours
    - No Parties on Tuesdays (Family Swim Night)
    - 6-8 pm
- Any patron renting the municipal pool facility is responsible to abide by the pool rules and regulations. Pool employees have the authority to remove or suspend persons from the pool area for violation of the rules and regulations or actions detrimental to the safe

and orderly operation of the pool. Failure to abide by the following rules and regulations can result in verbal warnings and time-outs for minor misconduct or suspension for major misconduct. In the event of serious misconduct, local law enforcement will be notified and if minors are involved, parents will be notified immediately.

### **Rules for Patrons**

**\*\*Children 8 and under must be accompanied by a patron 14 or older, subject to exceptions granted by pool manager.**

**\*\*The ONLY free admission is that of a supervising, street clothed adult or the immediate family of a City employee. (Spouse or children)**

- **Pool Patron Requirements**
  - Showers must be taken before entering the pool.
  - Swimmers must be attired in a swimsuit. Cutoffs and other makeshift swimsuits are not permitted. Clean white T-shirts may be worn.
  - Any injury occurring in the pool complex must be reported to management immediately.
  - Evacuation of the pool at 2:30 pm and 4 pm for approximately 15 minutes to perform routine maintenance
- **Denial of Pool Admission**
  - Those who have evidence of contagious disease, open wounds or sores, or any person known or suspected of being infected with any communicable disease shall not be admitted to the pool.
  - Persons under the influence or in possession of alcoholic beverages or narcotics will not be admitted to the pool.
  - Any patron that may be detrimental to pool operations, upon judgment of the pool manager
- **Prohibited Actions**
  - Use of abusive or profane language
  - Use of all tobacco products while inside the Pool complex. Smoking permitted in the parking lot.
  - Food or Drinks in the deck area. All food and drinks must be kept in the picnic area outside the pool house. Bottled water is the ONLY exception to this rule!
  - Use of glass bottles and containers
  - Running, dunking, riding on shoulders, fighting, rough play, pushing, or shoving, either in the water or on the deck
  - Diving in shallow areas
  - Pulling, hanging, or standing on pool rope
  - Jumping off of lifeguard stands
  - Visiting or talking to lifeguards while on duty
  - Bumming or Stealing
- **Diving Area Rules**
  - Only one person at a time permitted on diving board, including the steps
  - Only one bounce is permitted.
  - Inward dives and gainers are prohibited.
  - Sitting dives, cartwheel dives, or other non standing dives not permitted.
  - Diving off of either side of the diving board except the front end is prohibited.

- No loitering around or under the diving board.
- Properly fitted and USCG approved devices may be worn in the diving area with prior approval from the pool manager.
- **Infants through Preschool**
  - Pool patrons wearing diapers must wear swimmer's diapers.
  - Children age six (6) and under must be directly attended (within five (5) feet) by a responsible party.
  - Floatation devices are not recommended, unless properly fitted and USCG approved. With approval from the pool manager, these lifejackets may be used in the deep end of the pool or on the diving board.
- **Toys and Swim Equipment**
  - Patrons may use their own toys and equipment up to 36" in the shallow area if it does not pose a safety hazard or infringe on privileges of other patrons. Pool staff may prohibit toys or equipment if pool is overcrowded.
  - Sunglasses, hats, and visors may be worn in the shallow area if not swimming.
- **Items Prohibited**
  - Bandages
  - Bobby Pins
  - Oil based body lotions
  - Pets (with the exception of guide dogs)
  - Glass objects
  - Weapons of any type
